- Opportunities for seminars and events

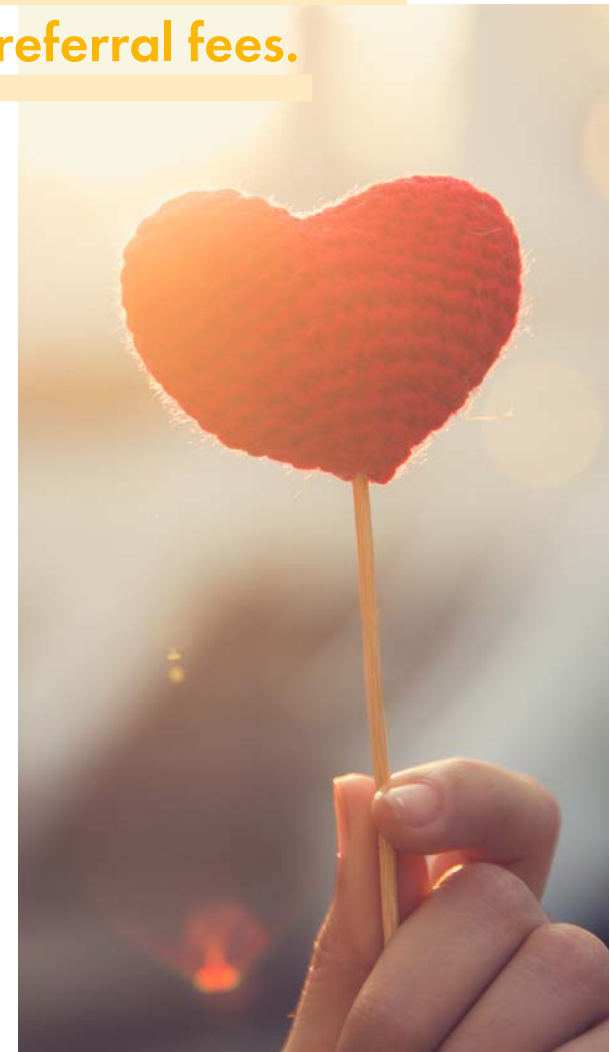
